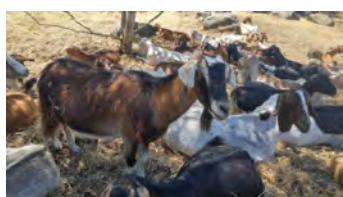

PRESIDENTS MESSAGE by Maureen Henderson

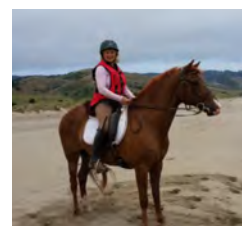

**LBHA Board and General Meeting Minutes
July 20, 2016**

Meeting was called to order by Maureen at 7:00 pm. The following Board members were present: Maureen Henderson, Pat Gibbs, Greg King, Barbara Lawrie, Dave Faoro, Bree Hendricks, Melanie Warlow. Committee Chairpersons present were: Liz Daffner. Not Present: Barbara Heyward, Janis Rau.

- New Members: Linda Thompson, Eileen Graves, Trish Brown.
- Maureen reported that Marty Courtney sent a thank you note for the gift card LBHA sent to him.
- Treasurers Report was not given as the Treasurer was absent.
- Trails Report: Pat Gibbs reported that a joint letter dated 07/16/2016 (from LBHA and FATRAC) was sent to California Department of Parks and Recreation and United States Bureau of Reclamation in support of the China Bar Bridge and Auburn to Cool Connector Trail. The letter will be published on the Website so members will have access. A copy was given to the Secretary for her records.
- McKeon Ponderosa Easement: Pat reported on Placer County's abandonment of an easement aka McKeon Ponderosa Road. A motion was made and seconded that LBHA write a letter in support of Placer County correcting the abandonment of the easement in order to maintain public access to the Historic Western States Trail (White Oak Flat) and also to alleviate financial responsibility for the homeowners who now own that easement. A public hearing is scheduled for August 1, 2016.
- Pat reviewed the final draft of the LBHA Trail Policy and suggested we circulate it one more time to the mountain bike community for further input. The Board agreed, and Pat will be responsible for sending it out.
- Traylor Ranch: Emails were submitted to the Secretary to confirm the purchase of a golf cart for Traylor Ranch. Maureen made a motion, seconded by Bree, that some type of monument be installed at the Ranch for Jerry and Linda Potter acknowledging their work and support of Traylor Ranch. The motion was unanimously passed and further discussion re the details was tabled to the next meeting. Dave reported on the redesign of the kiosk at the Humphrey Road entrance. Discussion on changing the work day when it falls on a 3 day weekend was tabled for future discussion.
- Horse Show: Kathy reported that all of the judges and announcers for the horse show scheduled for October 8 and 9 have been confirmed. Food and photography will be handled by Del Oro students. If anyone still wants photo from last year's show, they are still available.
- Dave Faoro motioned, seconded by Greg King, that we publish a list of current members together with the expiration date of their membership. The motion was tabled for future discussion.
- Old Business: The new member packet has been finalized and is available on our website.

There had been discussion at prior meetings on whether or not LBHA would provide helmets in the event there are juniors who would be unable to ride under the current requirement that all riders under 18 years of age must wear helmets at all events and horse shows. After discussions with attorneys and our insurance carrier, the answer is NO.

Pat Gibbs motioned to adjourn at 8:07

Thank you, ACE, and all who came and wrote letters in support of public access to public lands and public trails! Special kudos to Loomis Basin Horsemen's Association, Gold Country Trails Council (including the President, Laura Duncan) and ASRA Superintendent Michael Schneider, whose presence showed State Park's concern. They all were in attendance demonstrating the larger community's commitment to recreational trails and for pressuring the County to be part of a solution to the current problem of public access to the White Oak Flat staging area.

The good news is that the chair of the Foresthill Forum, Larry Jordan, who is well-aware of the local players and the history of White Oak Flat, has committed himself to leading an ad-hoc committee under the Forum. The County Supervisor would not let the Forum make a formal recommendation at this time, but Mr. Jordan will keep on it and promises the public will be advised of the committee's work.

In the meantime, it was entered into public record that the homeowners at the end of the street are themselves divided as to what they want and their views of public access; the privatizing of the end of the street occurred 25 years ago but that none of the homeowners started the process of trying to restrict public access until this spring despite continuous use by the public; and that White Oak Flat is a special place of historic and practical value for the general public as well as the local community.

All of us need to keep watch, keep up the pressure for solutions and constructive County involvement, and keep using the trails.

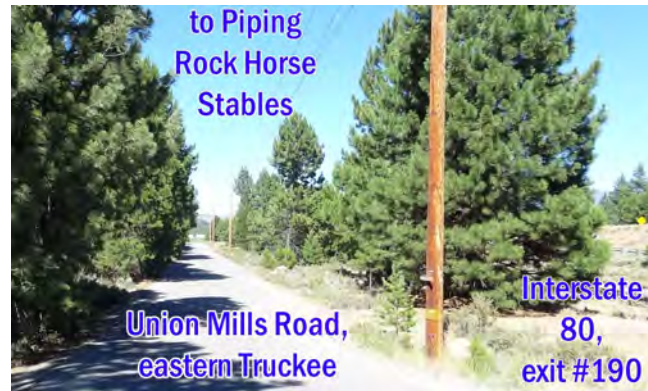

Introduction and Location

The Piping Rock Equestrian Center is located in northeastern Truckee, Nevada County. It is immediately adjacent to the State of California Agricultural Inspection Station on Interstate 80. Use Caltrans Exit #190 to reach Union Mills Road, then proceed eastward (as shown in upper right) to reach the stables and equestrian center.



The Piping Rock Equestrian Center has two large outdoor arenas and a covered indoor arena that is used for dressage and gymkhana. There are several excellent trainers that assist pre-teen riders (for ages 8 and up). Trainer Marcy Lawwill has decades of equestrian experience. Horses are available for rent and helmets are furnished and required (or bring your own). Go the website listed above for complete details and reservations. They will also take overnight or weekly boarders. Bring a health letter signed by your Veterinarian that your horse is up-to-date on vaccinations.

The six lanes of Interstate 80 are a formidable barrier for equestrian trails. However, Caltrans adroitly installed a spacious tunnel so that horses can go under the freeway. It did not appear to be either noisy or spooky for horses, despite the heavy vehicle traffic on Interstate 80.

ARENA:: Please NO TRAILERS or HORSES on the asphalt parking lot. ALSO, no barrels, poles or other equipment may be used in the arena. Small Orange cones are OK. Trainers must have an Arena Use form submitted annually as well as the proper insurance naming LBHA and Placer County as “Also Insureds.” If Insurance is cancelled 2 times or more, the permit is no longer valid. Trainers MUST contact LBHA with the time and number of students that will be in class, 24 hrs before the lesson. (All Forms are on LBHA Website at LBHA.us)

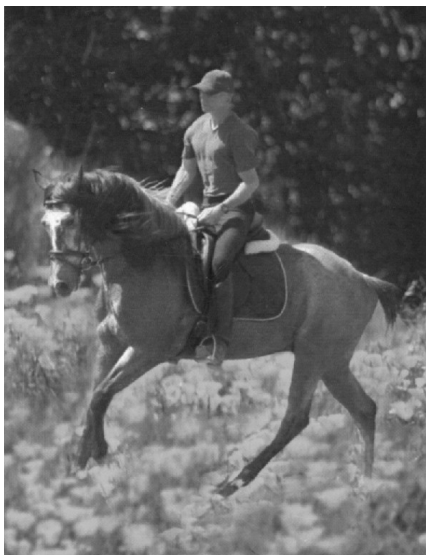

RELEASE AND HOLD HARMLESS AGREEMENT

The Undersigned assumes the unavoidable risks inherent in all horse-related activities, including but not limited to bodily injury and physical harm to horse, rider and spectator. The Undersigned acknowledges that horse-related activities are dangerous and that horses themselves have unpredictable temperaments which can sometimes cause injury. The Undersigned acknowledges that even the most experienced horse event sponsor, participant or horse owner cannot predict how each individual horse will react in a variety of situations and cannot guarantee my safety. THEREFORE, BY SIGNING BELOW, I KNOWINGLY ASSUME THE UNAVOIDABLE RISKS INHERENT IN ALL HORSE-RELATED ACTIVITIES, WHETHER KNOWN OR UNKNOWN, INCLUDING BUT NOT LIMITED TO BODILY INJURY AND PHYSICAL HARM TO HORSE, RIDER AND SPECTATOR, AND AGREE TO THE FOLLOWING ON BEHALF OF MYSELF AND MY SPOUSE, IF ANY:

1. I HEREBY RELEASE AND DISCHARGE LOOMIS BASIN HORSEMEN'S ASSOCIATION ("LBHA"), THE LBHA BOARD OF DIRECTORS, ALL LBHA OFFICERS AND INDIVIDUAL CLUB MEMBERS AND THEIR AGENTS, EMPLOYEES, OR REPRESENTATIVES, AS WELL AS PLACER COUNTY, (HEREINAFTER COLLECTIVELY KNOWN AS "RELEASEES") FROM ALL ACTIONS, CLAIMS OR DEMANDS I MAY NOW OR HEREAFTER HAVE FROM INJURY, DEATH OR DAMAGE RESULTING FROM MY PARTICIPATION IN ANY HORSE-RELATED ACTIVITIES SPONSORED BY LBHA, AT LOOMIS BASIN HORSEMEN'S ARENA OR AT ANY OTHER LOCATION.

2. I also EXPRESSLY WAIVE any rights I may have under California Civil Code §1542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."

5. I agree that I will DEFEND, INDEMNIFY AND HOLD HARMLESS Releasees against all claims, demands, and causes of action, including court costs and actual attorney's fees, arising from any proceeding or lawsuit brought against them due to any act done by me, or brought by me or for my benefit.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT CAREFULLY AND COMPLETELY, AND FULLY UNDERSTAND ITS CONTENTS.
