#### HALTER-GENTLED MUSTANGS, WILD HORSES AND BURROS AVAILABLE FOR ADOPTION IN ANGELS CAMP

**ANGELS CAMP, Calif.** – More than 20 wild horses, including animals gentled and trained to ride, will be offered for adoption Saturday and Sunday, March 19 and 20, at the Calaveras County Fairgrounds, 101 Frogtown Rd. in Angels Camp.

The Bureau of Land Management will offer 18 wild horses, two 3-year-old geldings gentled under a trainer incentive program, and three 5-year-old geldings trained by Rio Cosumnes Correctional Center inmates to saddle and ride. Eight burros also will be offered. Adoption event gates open at 8 a.m. each day. An auction of the saddle-trained horses is set for Saturday at 9 a.m. in Barn One South at the fairgrounds livestock area.

Silent bidding for the trained geldings and untrained horses and burros runs from 10 to 11 a.m. with bids starting at \$125. Horses and burros not adopted during silent bidding will be available for a \$125 adoption fee for the remainder of the event.

Anyone interested can preview all available animals starting at 4 p.m. Friday, March 18.

The adoption is being held in conjunction with the Backcountry Horsemen of California's Rendezvous. That event includes demonstrations, clinics and vendors focused on using horses for back country packing and exploring.

Horses and burros up for adoption are from public land ranges in northeast California and Nevada. They were removed from the range in the BLM's work to manage wild populations at sustainable levels.

The saddle trained horses are from a partnership between the BLM and Sacramento County Sheriff's Department in which jail inmates train wild horses for adoption and learn skills in equine care and training.

#### Golf Course Trails? No?

The 5<sup>th</sup> of February was my birthday. It was one I'll not forget. My 7 y/o Arabian Gelding, Murmullito FOA ("LG"), and I trailered to Sacramento Horsemen's Association (SHA), which borders Hagen Oaks golf course, to ride with a friend and her Off-The-Track-Thoroughbred, DOT (Department of Transportation). DOT is a granddaughter of Seattle Slew (Triple Crown Winner) A major problem on the trails near SHA is the many, many homeless people who put up tents right in or on the trails, leave all kinds of trash and garbage around, pop up when least expected, etc., etc.



We were riding along a trail which runs between Longview Drive and

the golf course. The trail is bordered on both sides by fencing. The fences are 6' high chain link topped with 5 strands of barbed wire (think Folsom Prison). The chain link has been cut and bent away with 10' wide areas of no fence in several areas; but these areas are still topped with taut barbed wire. As we rode along, one of the homeless guys outside the fence that borders Longview Drive stood up suddenly, spooking both horses. LG was in the lead as DOT is a bit of a princess. He was next to one of the gaps in the fence on the golf course side of the trail. I tried to get him stopped, but there wasn't room or time as he whirled to the right and started to scoot through the hole. Remember, there's 5 strands of barbed wire above the gap. As LG squirted through the gap and I saw the barbed wire about chest high on me, I dropped the reins and grabbed the barbed wire with both hands and hung on. The wire was very taut, so I didn't slide. I came neatly out of the stirrups, hung for a few seconds by my hands, then dropped to the ground. My friend said it looked planned or choreographed as I just swung out of the saddle backward, then dropped to the ground running. BTW, I had on riding gloves and yes, my hands did get a few minor cuts.

I was running because LG was on the golf course, galloping up a fairway, reins and stirrups flying. I hoped one of the golfers in a cart would give me a ride, but most barely hesitated. I pictured the worst, which would be LG getting onto Longview Drive or I-80 or falling into the canyon cut by a creek across the fairway. He was receding into the distance, about 200 yards away, when I saw him turn around, stop, look, then start cantering back toward me. Perhaps he'd just realized I had come off so wasn't having as much fun as he was, galloping up the fairway. I envisioned a game of catch-me-if-you-can, but he trotted right up to me, then stopped. Some cynics suggest he was coming back to DOT (still behind the fence with her rider), but I think he was hoping for treats.

We mounted up and rode the trails for 2 more hours. The rest of the ride was only mildly exciting (lots more homeless people popping up, but with less challenging results). Our Competitive Trail (NATRC) season starts in May. We should be well prepared if we encounter trains (see Our First Great Adventure), bridges, semi-tractor trailer rigs, water crossings, bicycles, runners, tents, blowing trash, golfers teeing off, or pop-up people. What a welcome to my 70s!

BTW, I told the administration at SHA what had happened. So far, I've received no bill (at \$50 per divot that has been rumored) from Hagen Oaks. Apparently, LG is not the first horse to leave hoofprints on the course.

#### Sauerkraut Juice ~ June Havecost

Years ago, I had a mare (really nice mare who went on to be an AQHA Reserve World Champion, AQHA Champion and Superior) that had a big blaze and 2 high white hind socks. She got "scratches", which I'm sure are known by many names. For those who don't know what "scratches" are it is a type of fungus that usually is attracted to white hair/white skin and can happen anywhere on the body but usually happens on white socks and then can travel to other areas of white skin. It usually occurs in an atmosphere of dry then wet and dry and then wet usually in some muddy pens (altho this mare was not kept in a muddy pen). It appears to be a wet/dry scabby area in patches.

Well the mare got scratches and we tried everything (almost, I'll explain later) known to man; steroids, all kinds of topicals, wrapping dry—I can't remember everything we tried but we tried everything! This went on for 6 months or more and at the end of my rope I began calling anyone and everyone that I knew had any information about horse care asking if they had any information or recommendations for "scratches". I ran into a gal that used to be a galloper at a race track and she told me of an application the track used for "scratches". I was beyond being put off by how stupid/silly the solution sounded and was willing to try anything. If you're a horse owner, you know 6 months of something that's not working gets REALLY old! So, I started the regime with lots of hope! Good astringent soap, disposable diapers and a can of sauer-kraut juice (depends on the store whether you can buy the juice or have to buy sauerkraut and separate the juice).

Scrub the infected area and let it dry; keeping it clean while drying. Pour some sauerkraut juice in the disposable diaper and wrap the leg with the juicy diaper; follow up by wrapping the leg with a leg wrap to hold it in place. Do this repeatedly until the skin is clean, pink and healed. At first, the scabs will have to soften and the wounds will be open followed by the skin being "seared/cauterized" by whatever is in the sauerkraut juice that kills the fungus—finally new pink hairless skin. And, if scratches has not completely run it's course it will come back and you will have to repeat the procedure allowing more time for healing. I said earlier that I tried ALMOST every solution I was told about. The one I didn't try, altho it's the same basic principle—to sear the skin, kill the virus and allow new uninfected skin to grow. I had friends that had brought in the very first AQHA stud to Colorado so they were LONG TIME horse/ranch people that found natural solutions to their problems with their ranch and their livestock. They bred and raised quarter horses and were a respected/down to earth ranching family. When they had to treat scratches they would tie the tail up, pour turpentine on the scratches area and throw a match to it.

Colorado Ambulatory Vet Service now carries sauerkraut juice on their trucks for ranch calls!!!!

#### Seven Pools Vista Trail

Hidden Falls Regional Park, Placer County, California by Robert H. Sydnor, Hydrogeologist and AERC Trail Master March 2016

#### **Introduction and Location**

The Seven Pools Vista Trail is a splendid trail within Hidden Falls Regional Park, located in southwestern Placer County, about six miles northwest of Auburn.



From the parking lot, ride your horse along constructed trails across the Whiskey Diggins Bridge and ascend Turkey Ridge. Turn east and follow the crest of Turkey Ridge to the beginning of **Seven Pools Vista Trail** (refer to signpost at lower left).

This trail is only about 0.7-miles long, but it is interconnected with many other looping trails, so that your total distance will typically be on the order 8 to 10 miles, or more, depending on available time and weather. There are about 30 miles of trails within this Placer County park, and additional trails are planned.

Take it home with you.




