Preparation of new Master Plan for Parks and Trails within Placer County

On October 25, 2016, the Placer County Board of Supervisors voted to retain a consulting planning firm to develop a **Ten-Year Master Plan for Parks and Trails** within Placer County. In early 2017 there will be a number of meetings of **"focus groups"** to provide input from citizens and stakeholders. Various equestrian organizations who are vitally interested in trails within Placer County need to provide one trails expert who is also qualified in long-range planning (with one designated alternate) to participate in upcoming meetings in Auburn.

This is an important opportunity for a number of equestrian groups in the Placer County and the Mother Lode region to be involved in the development of the Ten-Year Master Plan for Parks and Trails. It is important for equestrians to realize that they need to participate with a **unified and consistent voice** during the long-range planning process. This means: no internal squabbling. **Consensus building is needed among equestrians.** This is not about current predicaments with strident opinions, but instead, is a **long-term prescient vision** for the next ten years.

Placer County Parks Administrator Andy Fisher has informed equestrians that the new Master Plan will include consultations and coordination with Nevada County trails, trails within the Auburn State Recreation Area, and the U.S. Forest Service (= Tahoe National Forest, American River Ranger District in Foresthill). After all, when we equestrians ride a horse across an unseen political boundary, the horse only cares about the **connectivity of the trail**, its **proper trail maintenance**, and whether (or not) the **new timber bridge** was built to published federal standards for equestrian bridges. Equestrians want all new timber bridges to be properly built to federal standards. For example, several *new* timber bridges within ASRA do not meet long-time published federal standards (weak structural railings; lack of guide railings at the bridge approach).

Local equestrians who use Hidden Falls Regional Park will be pleased to learn about the park expansion with an increase from about 30 miles of trails (currently) to a potential of about 60 miles in the future. But local equestrians have adversely learned that horse-trailer parking is a serious issue at Hidden Falls Regional Park. The parking lot is severely congested by hikers and mountain bikers on weekends. Horse trailers need a lot of extra space for adequate parking. Therefore, prescient and far-sighted planning would include larger parking lots closer to the Bear River that are *only* for horse trailers.

A collateral insight is the ASRA Olmstead Loop at Cool in El Dorado County: there are two entirely *separate* parking lots: one dedicated for horse trailers, and another one (near the fire station) that is *only* for hikers and mountain bikers. **Separate parking lots** are created by prescient long-range planning, not by happenstance.

Another relevant example is the equestrian assembly area at the Auburn Overlook. This parking lot is *only* for equestrians, and it is a \$10 fee-based parking lot. But adjacent to the south, is an entirely free parking lot for automobiles that is used by hikers and skateboarders. This is a notable win-win situation for equestrians. The free parking lot is owned and operated by the Auburn Recreation District, and it is properly signed for NO horse trailers (and we equestrians quickly agree with that restriction, since we prefer separate parking lots).

The presidents of Mother Lode equestrian organizations need to nominate their **qualified trails specialist** to participate in the development of the Ten-Year Master Plan for Parks and Trails within Placer County. Trainers must have an Arena Use form submitted annually as well as the proper insurance naming LBHA and Placer County as "Also Insureds." If Insurance is cancelled 2 times or more, the permit is no longer valid. Trainers MUST contact LBHA with the time and number of students that will be in class, 24 hrs before the lesson. New Acting Superintendent within the Auburn State Recreation Area, California Department of Parks & Recreation

The new Acting Superintendent for the Auburn State Recreation Area, California Department of Parks and Recreation, is Michael Howard. His cell phone number is 530-823-4173, and the general phone for ASRA Headquarters remains 530-885-4527.

In November 2016, the former ASRA Superintendent, Michael Schneider, transferred to become the California State Parks Superintendent for the Sacramento Historic District. His office is within Sutter's Fort. We miss Michael Schneider a lot; he was very helpful to equestrians.

Equestrian groups within the Placer County and Mother Lode region will need to update their newsletters and directories with the current administrative information for the Auburn State Recreation Area.

ASRA is still working on its new General Plan. However, planning process is seriously behind schedule because the U.S. Bureau of Reclamation is "very slow" for multiple adverse reasons. One planning meeting was held for the general public on November 12, 2015. It was heavily attended at a public school auditorium in Auburn by hundreds of interested citizens. But there has been no progress for over one year because of the Bureau of Reclamation has internal problems (retirements of previously knowledgeable staff, new federal staff who lack planning abilities, etc.). Therefore, equestrian groups should not blithely assume that everything is all right for the ASRA General Plan, when (frankly) it is not.

Placer County is currently developing a new Ten-Year Master Plan for Trails, and this includes continuity of trails within the Auburn State Recreation Area. Sadly, there is nobody within ASRA to coordinate the trail planning process. Equestrians would like to see a smooth planning process for horse trails at the County-State level but this is currently lacking.

For example, equestrians would like to see the washed-out bridge rebuilt across the American River for trail access from Oregon Bar (near the site of the ill-fated Auburn Dam) directly to the Olmstead Loop.

Secondly, the current Park Ranger staff within the Auburn State Recreation Area is seriously short-handed due to transfers, lateral promotions to other state parks, and retirements of long-time knowledgeable ranger staff.



Hidden Falls Regional Park Trails Network Expansion Project

Placer County is requesting **your involvement** in planning the future of Hidden Falls Regional Park. The county is in the beginning planning stages for the **expansion of the trail system** from Hidden Falls Regional Park to the Bear River. Through the county's partnership with the Placer Land Trust, more than 2,500 acres of open space near the park has been acquired for preservation of oak woodland, wildlife habitat and public recreation through additional trails.

At completion, the expansion of the park could result in **4,000 acres** of contiguous open space with a trail system approximately **60 miles** in length.

The next steps for the Hidden Falls expansion will be **public outreach** and **environmental review**. Before any physical expansion of the existing trail system on these other parcels is undertaken by the County, this process will analyze existing use, traffic patterns and the **current parking situation**.

As many of you know, visitation at Hidden Falls has increased dramatically since its 2013 opening. Using actual data from current use will help us plan for long-term management strategies, provide for sustainable parking solutions which limit impacts on adjoining neighborhoods, improve the current user experience and define future opportunities.

Study Locations:

The proposed expansion areas are located north and northeast of the existing park and consist of the areas known as **Taylor Ranch** (321 acres) and **Harvego Bear River Preserve** (1,773 acres), as well as privately-owned parcels with trail easements, such as the **Liberty Ranch** (313 acres). The trails will also cross the **Kotomyan Preserve** (160 acres) and the **Outman Big Hill Preserve** (80 acres). Please refer to the map for the locations of these properties in relation to the existing park area. In addition to the expansion of the multi-use trail network, the project would include **two bridges across Coon Creek**, parking areas, roadway improvements, and other park amenities that would meet the high demand for trails, reduce overflow parking on local roadways, and increase public safety.

Study Process:

The county is in the early stages of planning and will be conducting **biological and cultural resources surveys**, traffic counts on area roadways and **trail mapping** to gather information to support the required planning and permitting documents. The trail layout will be designed to maximize the use of existing trails and roadways and minimize disturbance of natural resources.

Additional parking opportunities will be explored as a part of the environmental review process. Please be aware that the county will be conducting the traffic and natural resources studies described above in December 2016, and again in the spring of 2017.

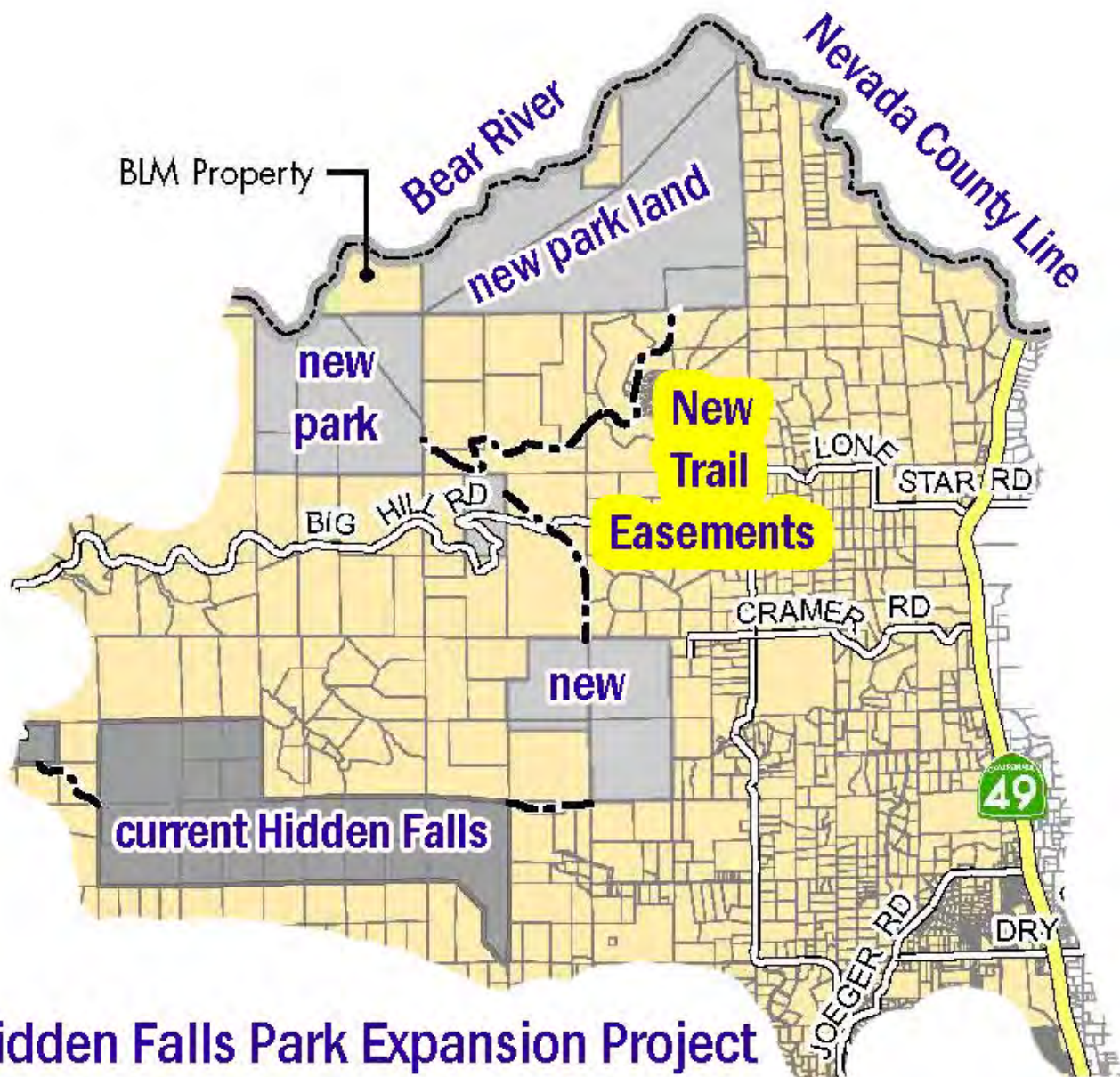

Andy Fisher is now deeply involved with the new 2017 Master Plan for Placer County Trails, and the third phase of park acquisition for Hidden Falls Regional County Park.

The new Senior Planner will be particularly involved with the preparation of the new Master Plan for Placer County Trails, and the Supplemental E.I.R. for the expansion of Hidden Falls Regional Park with its linking trails system leading northwestward into Nevada County.

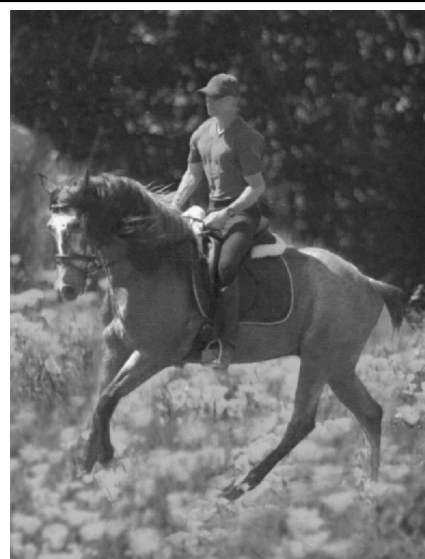

RELEASE AND HOLD HARMLESS AGREEMENT

The Undersigned acknowledges that horse-related activities are dangerous and that horses themselves have unpredictable temperaments which can sometimes cause injury. The Undersigned acknowledges that even the most experienced horse event sponsor, participant or horse owner cannot predict how each individual horse will react in a variety of situations and cannot guarantee my safety. THEREFORE, BY SIGNING BELOW, I KNOWINGLY ASSUME THE UNAVOIDABLE RISKS INHERENT IN ALL HORSE-RELATED ACTIVITIES, WHETHER KNOWN OR UNKNOWN, INCLUDING BUT NOT LIMITED TO BODILY INJURY AND PHYSICAL HARM TO HORSE, RIDER AND SPECTATOR, AND AGREE TO THE FOLLOWING ON BEHALF OF MYSELF AND MY SPOUSE, IF ANY:

1. I HEREBY RELEASE AND DISCHARGE LOOMIS BASIN HORSEMEN'S ASSOCIATION ("LBHA"), THE LBHA BOARD OF DIRECTORS, ALL LBHA OFFICERS AND INDIVIDUAL CLUB MEMBERS AND THEIR AGENTS, EMPLOYEES, OR REPRESENTATIVES, AS WELL AS PLACER COUNTY, (HEREINAFTER COLLECTIVELY KNOWN AS "RELEASEES") FROM ALL ACTIONS, CLAIMS OR DEMANDS I MAY NOW OR HEREAFTER HAVE FROM INJURY, DEATH OR DAMAGE RESULTING FROM MY PARTICIPATION IN ANY HORSE-RELATED ACTIVITIES SPONSORED BY LBHA, AT LOOMIS BASIN HORSEMEN'S ARENA OR AT ANY OTHER LOCATION.
