**From a Member:**

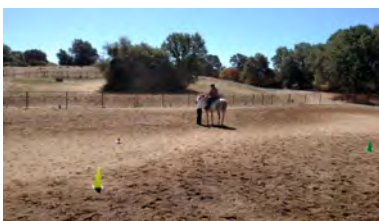
Regarding the closing of McKeon Ponderosa Way, here is an update. It is imperative that State Parks/ASRA and BLM hear from the public prior to a scheduled Foresthill Forum meeting August 1 (the Foresthill municipal advisory committee), when all stakeholders will be asked to be present.

Access to White Oak Flat (BLM/BOR land) and ASRA Gate 102 to Francisco's and beyond has become a complex issue. There are a few homeowners towards the end of McKeon Ponderosa Way who have wanted for years to have a gated community, for various reasons. In 2002, when this issue came up, County Public Works clearly informed everyone that public use of their end of the road could not be denied. However, one of those homeowner recently discovered an old document from the County apparently abandoning that portion of the road in the late 1980's! He has put up private road signs and wants to put in a gate. Now the County appears to be looking for BLM/ASRA to step up and state it is against **their** wishes for the public to be denied access to these long-used public lands. Thus everyone needs to contact these public agencies if historic White Oak Flat and the trails leading out from McKeon Ponderosa Way are to be protected for all to use! We need a dedicated public easement to the White Oak Flat staging area! Let us see all of our public agencies work together to protect the **public's** interest in one of Foresthill's best assets, its recreational trails! **Western Dressage Clinic with Vivian Mevorah**

Vivian Mevorah volunteered her time on Sunday June 26th to present a free Western Dressage clinic to LBHA members. She explained the practical use of Western Dressage in training a responsive and supple horse. This is especially important when riding on the trail or moving cattle to get a job done. Western Dressage is ultimately *training*, and you go to shows to gain feedback on your progression through the levels.

The origination of Dressage dates back hundreds of years when war horses needed to be taught how to maneuver in battle. Each Dressage move has a purpose, but before you can do the fancy stuff, your horse has to learn balance.

A total of 7 riders attended and worked on riding a balanced circle at the walk and jog. She explained that horses off the range don't understand how to use their powerful hind quarters for propulsion and collection. We have to teach softness in their body and build muscle for collection. The end goal is for our horses to perform with a soft whisper.

Practicing a circle correctly encouraged the horses to listen to their riders cues, find their cadence, and bend at their rib cage for a supple body. It was great to watch each horse/rider find their groove in the circle with Vivian's help.

2016 has seen several great clinic including the 3 part Dressage series with Marty Courtney earlier this year.

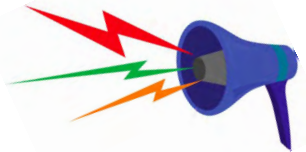

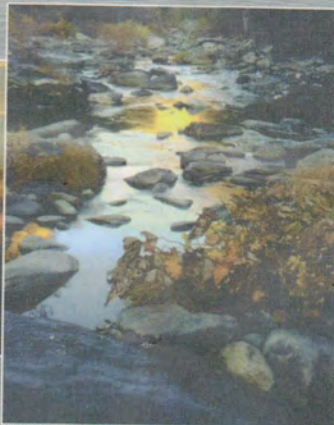

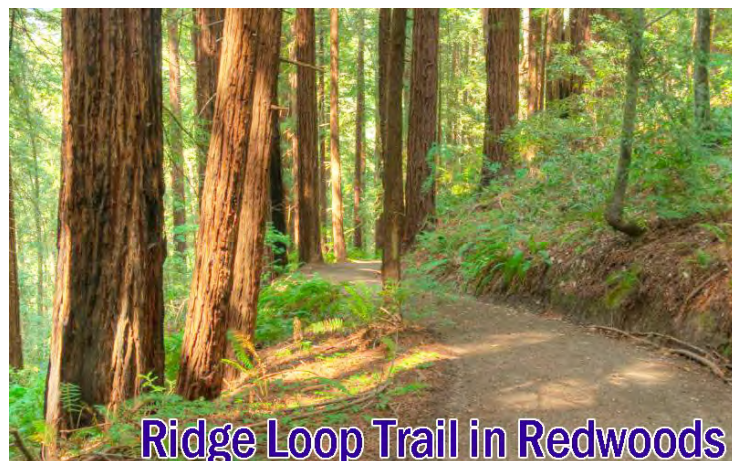
### Introduction and Location

One of the finest horse camps in the San Francisco Bay area is in the hills southwest of Stanford University within San Mateo County. The Jack Brook Horse Camp is one of several public campgrounds and picnic areas within 850-acre Sam McDonald Park that is part of the San Mateo County park system.

From Highway 101 or Interstate 280: Take Highway #84 (Woodside-La Honda-San Gregorio Road) west to the village of La Honda.

Turn left ½-mile past village center in La Honda onto Pescadero Road. The park entrance is on Pescadero Road, and 6 miles from the turn-off.

## Horse Camping Fees and Equestrian Amenities

Within Jack Brook Horse Camp are three separate areas for groups of different sizes. Rents are higher on the weekends and lower on the week-days; this is certainly fair. Popular holiday weekends are booked-out months in advance by equestrian groups from the San Francisco Bay Area. There are **no cancellations** for rainy weather. **No dogs** are allowed within the entire county park. The horse camp is open **May 1st through November 15th**. Expect hot summer days, cool nights and occasional heavy fog.

Among the amenities of Jack Brook Horse Camp are **showers** and **restrooms**, a **horse wash-rack**, and an **outdoor kitchen** with **electrical plugs, refrigerator, freezer, and microwave** (shared by all the camps). The area offers **48 horse paddocks** and **6 tie posts** available on a first-come/first-serve basis. **Portable corals are permitted** and firewood is available for purchase. Remember to bring rain gear during the early and late season. **Parking is shared** among all park users and is available on a first come, first served basis. Your equestrian group must **rent the entire unit** (then evenly divide the rental costs among yourselves), as shown below:

**Area #1 with 40 camps**, at **\$275 per night** on Friday and Saturday nights for the complete unit (or about \$6.25 per campsite if you have a maximum group of forty horse trailers). Sunday through Thursday nights, the rental is much lower at **\$150 per night** for all of Area #1 (or about \$3.75 per campsite if you have a maximum group of 40 horse trailers). This site is approximately 500' x 150' and has dirt and wood chip surface with a 5% slope. There are four barbecues, 14 picnic tables, and 20 electrical plugs. The surrounding vegetation is made up of **redwood and live oak**, which provides **some shade**.

**Area #2 with 10 horse camps**, at **\$150 per night** on Friday and Saturday nights for the complete unit (or about \$15 per campsite if you have a maximum group of ten horse trailers). Sunday through Thursday nights, the unit rental is much lower at **\$75 per night** (or about \$7.50 per campsite if you have a maximum group of ten horse trailers). This site is approximately 50' x 30' and has dirt and wood chips surface with a 5% slope. The surrounding vegetation is made up of **eucalyptus trees**, which provide **very little shade**. There is one barbecue and two picnic tables.

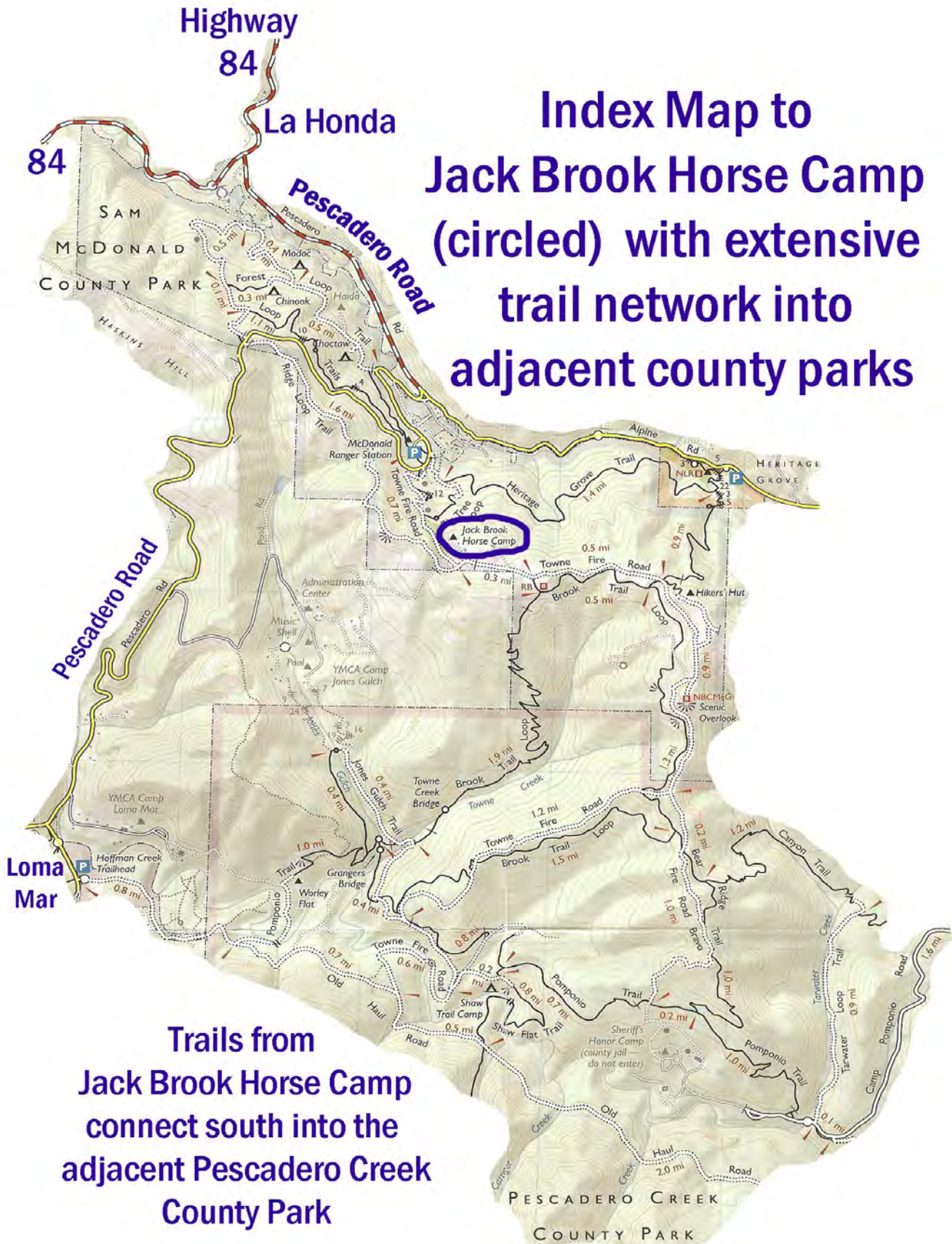
**Area #3 with 10 horse camps**, at **\$150 per night** on Friday and Saturday nights for the complete unit (or about \$15 per campsite if you have a maximum group of ten horse trailers). Sunday through Thursday nights, the unit rental is much lower at **\$75 per night** (or about \$7.50 per campsite if you have a maximum group of ten horse trailers). This site is approximately 500' x 150' and has dirt and wood chip surface with a 5% slope. The surrounding vegetation is made up of **redwood and live oak**, which provides **some shade**. There is one barbecue and two picnic tables.

**Heartfelt Condolences to the Potter Family  
on the Death of Jerry Potter**

On Thursday, June 16, 2016, Jerry Potter had just finished a wonderful ride with his wife, Linda, on the Olmstead Loop in Cool, within the Auburn State Recreation Area. As experienced equestrians, both were wearing helmets. Jerry's horse spooked and Jerry lost his balance and fell. Two considerate hikers stayed with Linda until help could arrive.

Members of the Loomis Basin Horsemen's Association convey our heartfelt condolences to the extended Potter Family. Jerry was a retired aeronautical engineer who worked professionally on the Boeing Stealth Fighter. Jerry is survived by his beloved wife Linda; daughter Kelly Hill of Bend, Oregon; son Randy Potter (a petroleum engineer with Chevron in Colorado); and Timothy Potter (a petroleum engineer with Chevron in Louisiana). All three of Jerry's children immediately came from out-of-state to assist their mother at the family ranch.

At a later date, there will be a private ceremony whereby Jerry's ashes will be solemnly taken to the Pacific Ocean at Point Reyes. Linda and Jerry enjoyed many days of horse camping at Point Reyes.

We ask that any memorial funds be donated to Alzheimer's Foundation on Jerry's behalf.

The Potter Family is still in the extended process of grief, so there is no memorial biography at this immediate date.

Besides LBHA, the Potters were extensively involved with Elegant Ears Mule Club, Backcountry Horsemen of California (Mother Lode Unit), Gold Country Trails Council, and the Action Coalition for Equestrians. The Potters have worked extensively to build new horse-camps within El Dorado National Forest along the South Fork of the American River drainage on the Highway 50 corridor, particularly Sayles Canyon Horse Camp, Tells Creek Horse Camp, and Caples Creek Staging Area along the Silver Fork.

Jerry will be missed.

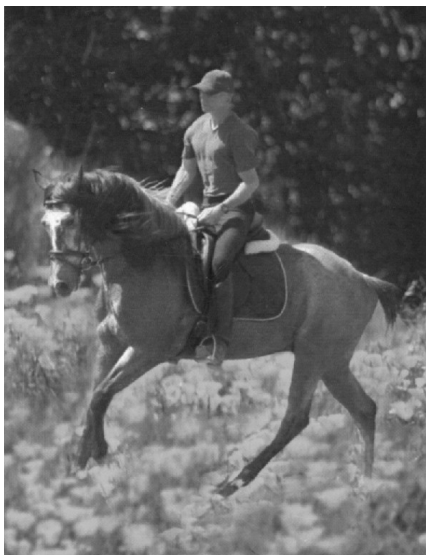

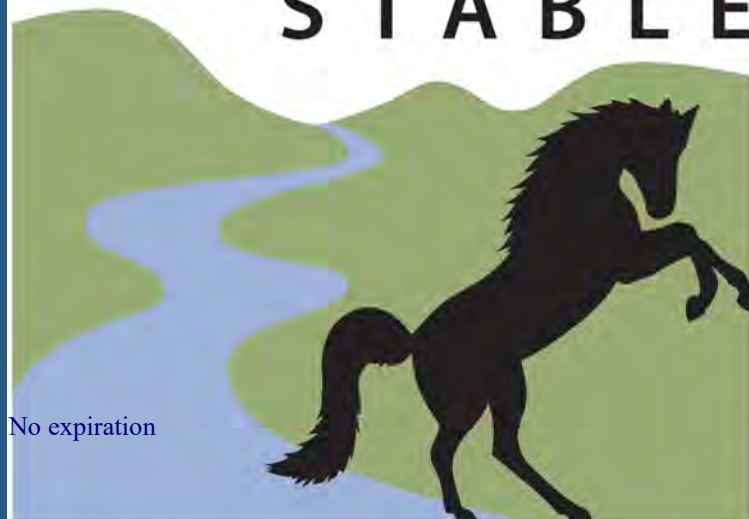

The Undersigned acknowledges that even the most experienced horse event sponsor, participant or horse owner cannot predict how each individual horse will react in a variety of situations and cannot guarantee my safety. THEREFORE, BY SIGNING BELOW, I KNOWINGLY ASSUME THE UNAVOIDABLE RISKS INHERENT IN ALL HORSE-RELATED ACTIVITIES, WHETHER KNOWN OR UNKNOWN, INCLUDING BUT NOT LIMITED TO BODILY INJURY AND PHYSICAL HARM TO HORSE, RIDER AND SPECTATOR, AND AGREE TO THE FOLLOWING ON BEHALF OF MYSELF AND MY SPOUSE, IF ANY:

1. I HEREBY RELEASE AND DISCHARGE LOOMIS BASIN HORSEMEN'S ASSOCIATION ("LBHA"), THE LBHA BOARD OF DIRECTORS, ALL LBHA OFFICERS AND INDIVIDUAL CLUB MEMBERS AND THEIR AGENTS, EMPLOYEES, OR REPRESENTATIVES, AS WELL AS PLACER COUNTY, (HEREINAFTER COLLECTIVELY KNOWN AS "RELEASEES") FROM ALL ACTIONS, CLAIMS OR DEMANDS I MAY NOW OR HEREAFTER HAVE FROM INJURY, DEATH OR DAMAGE RESULTING FROM MY PARTICIPATION IN ANY HORSE-RELATED ACTIVITIES SPONSORED BY LBHA, AT LOOMIS BASIN HORSEMEN'S ARENA OR AT ANY OTHER LOCATION.
